## **1 INTRODUCTION**

#### Clarification of some of the target groups

#### Public health officers:

Professionals working at public health institutes/authorities on national, regional or local level having one or more of the following responsibilities:

- Preparedness planning for responding to public health events at PoE, and/or
- Decision making for implementing health measures (e.g. exit/entry screening) at PoE, according to Decision 1082/2013/EU and the International Health Regulations 2005 (IHR) WHO temporary recommendations.

#### Airport officers:

Persons working at an airport or in the air travel sector (PoE designated in accordance with the IHR, or other 'non-designated PoE that are of public health significance), responsible for preparedness planning and/or – public health event management at airports

#### Port officers:

Persons working at a port or in the maritime travel sector (PoE designated in accordance with the IHR, or other 'non-designated PoE that are of public health significance), responsible for preparedness planning and/or – public health event management at ports

#### Ground crossing officers:

Persons working at a ground crossing (PoE designated in accordance with the IHR, or other 'nondesignated PoE that are of public health significance), responsible for preparedness planning and/or – public health event management at ground crossings.

## **6 PROCESS FOR UPDATING**

Both the catalogue and training materials are available on the website of EU HEALTHY GATEWAYS. Training materials can be downloaded and modified to the specific needs of an event, depending on the local context.

Users are encouraged to add comments and to send in their modifications and/or adjustments in order to improve all materials and keep on building this catalogue. We propose to establish a small dedicated unit able to update the catalogue regularly with new or improved training materials under the framework of secretariat support services assigned to the *Public health observatory in means of transport and points of entry* under the Laboratory of Hygiene and Epidemiology of the University of Thessaly.
